Terms and conditions of the loyalty member card Camping 2.0

1. - The loyalty program Camping 2.0 (in forward Card or Camping 2.0) belongs to Camping International la Marina. Only people over 18 years old can be holders of the Card Camping 2.0, and only one ownership card Camping 2.0 will be possible, per person. It's not allowed to

transfer or sell the benefits card. Presentation of the card is essential to obtain the current benefits and the presentation of the holder's ID, may be required to exchange any promotion.

2. - All those customers of Camping International la Marina, with a stay, a confirmed booking, or previous and existing customer who are also registered with www.camping20.es, can get the member card Camping 2.0. The campsites reserve the right to modify at any time, the terms of the benefit program.

3. - The benefits and discounts will be published on the web www.camping20.es. The offers can change at any time and are subject to the availability of the product and its use depending on the service. The discounts are not cumulative (unless indicated otherwise) and may not be applied on the specially offered rates. The Campsite will accept bookings, according to minimum nights. The minimums can decrease as we approach to the reserved dates. Check the minimums with Reception.

4. - A client may get the full benefits of the card Camping 2.0 from the moment that he is identified as the card holder with a card number.
